

COMMERCIAL ITEM DESCRIPTION

CIRCUIT BREAKER, AUTOMOTIVE TYPE

The General Services Administration has authorized the use of this commercial item description (CID) for all federal agencies.

1. **SCOPE.** This CID covers the general requirements for an automotive type circuit breaker. Circuit breakers covered by this CID are intended for commercial/industrial applications.
2. **CLASSIFICATION/PART OR IDENTIFICATION NUMBER (PIN).** This CID uses a classification system which is included in the Part Identification Number (PIN) as shown in the following example (see 7.1).




3. SALIENT CHARACTERISTICS.

- 3.1 **Interface and physical dimensions.** Automotive circuit breakers supplied to this CID shall be as specified herein (see figure 1) and shall meet the requirements of SAE J553 for automotive type circuit breakers.
 - 3.2 **Ampere rating.** The ampere rating shall be as specified in table I.
 - 3.3 **Voltage rating.** The voltage rating shall be 12 V dc.
 - 3.4 **Termination style.** The termination style shall be 10-32 threaded studs and shall be supplied with lock washers and hex nuts (see figure 1).
 - 3.5 **Marking.** Circuit breakers supplied to this CID shall be marked with the manufacturer's (MFR's) standard commercial PIN. The part number marked on the unit pack shall be the CID PIN.
4. **REGULATORY REQUIREMENTS.** The offeror/contractor is encouraged to use recovered materials to the maximum extent practicable, in accordance with paragraph 23.403 of the Federal Acquisition Regulation (FAR).

5. PRODUCT CONFORMANCE PROVISIONS.

5.1 Product conformance. The products provided shall meet the salient characteristics of this CID, conform to the producer's own drawings, specifications, standards, and quality assurance practices, and be the same product offered for sale in the commercial market. The Government reserves the right to require proof of such conformance.

6. PACKAGING. Preservation, packing, and marking shall be as specified in the contract or order.

7. NOTES.

7.1 PIN. The PIN should be used for Government purposes to buy commercial products to this CID. See section 2 for PIN format example.

7.2 Commercial and Government Entity (CAGE) code. For ordering purposes, inventory control, and submission of these automotive circuit breakers to DSCC under the Military Parts Control Advisory Group (MPCAG) evaluation program, CAGE code 58536 should be used.

- a. CID document number, revision, and CID PIN.
- b. Product conformance provisions.
- c. Packaging requirements.

At the time of CID preparation and coordination, these manufacturers were known to have commercial products that would meet the requirements of this CID. (NOTE: This information should not be considered as a list of approved manufacturers or be used to restrict procurement to only the manufacturers shown.)
